RENEWED HOPE FOR KEY LEGISLATION

At this writing, Senate Democrats are two votes short of their quest for 60; but hope that support from a few moderate Republicans will allow them to pass bills that were halted in the last Congress by GOP parliamentary roadblocks. The Washington Post reported that Democrats are counting on Maine Senators Susan Collins and **Olympia Snowe** to provide the votes to block filibusters. Senate Finance Chairman **Max Baucus** (D-MT) is drawing up a health-care plan while Edward **Kennedy** (D-MA) is drafting his own proposal. However, Senate aides say that internal divisions among Democrats make it difficult to handicap the outcome of the biggest issues this year, including these comprehensive efforts to secure universal health insurance.

Democrats have voiced renewed hope of giving the Department of Health & Human Services the authority to negotiate with pharmaceutical companies for lower prescriptions drug prices for seniors who participate in the Medicare Part D program. Shortly after taking power in 2007, House Democrats approved legislation for such authority (over the objections of the pharmaceutical companies and their lobbyists); but the plan failed in the Senate receiving only 55 votes in April 2007.

The good news is that Six Republicans who voted against the bill back then have since retired or were defeated and have been replaced by Democrats who are likely to support this measure.

- + Union members identified protecting pensions and Social Security and reducing health care costs as the top priorities for the next administration.
- + 75% say the new President and Congress have a mandate to strengthen the economy, create jobs and reform health care.

+ 81% of union members support passing the Employee Free Choice Act.

This proved that those Labor to Labor still must be waged. walks, phoning union members to turn out the vote, holding worksite meetings,


