As a result of the major union organizing campaign which began in January 2005 and culminated with the settlement agreement negotiated in August 2008 between CWA and Verizon, CWA Local 1103, welcomes forty-two new union Members into its ranks.

We thank the former Verizon Business employees who had the fortitude and courage to fight the threats and anti-union poison permeating within the walls of Verizon, the Ve-

rizon Core CWA Members who helped "Tear Down the Wall" by standing up for their new brothers and sisters by always keeping the fight in the forefront, and CWA Local 1103 organizer Fran Gottron for his dedication and contribution in making this a reality.

Effective December 28, 2008, the work of Thirteen-State/DC Area Apprentice Technicians, Technicians, and Senior Technicians employed by Verizon Business in its Operation Support Centers

and the work of those employed by Verizon Business which perform other types of defined work became Union. The service company established is the sole contractor for this work and shall perform the work exclusively and is now party to the labor agreement with CWA. There were approximately 600 Verizon Business employees in such positions in the Thirteen-State/DC Area, and they are now CWA Members.

Bringing along forty-

two new union Members at the same time is not an easy task; it sometimes seems that there are more questions than answers. The effort has proved even more difficult due to "carve outs" that were negotiated which eliminates some language within the plant contract for those new Members. Some contractual articles apply to all Verizon Members and some contractual articles apply to only Verizon Core Members. The learning curve for everyone



Scholarships



In My View . . .



After serving two tours in Vietnam, Christopher Cutter came to New York in 1969 and applied for a job with the New York Telephone Company due to his Army background in communications. However, his job in the telephone company led him on another career path. He became

involved in Local 1103 and has been working for the Union since 1974.

As Assistant to the President, he worked tirelessly on behalf of the Members. He is the editor/writer of the Union's newspaper, which has received over 40 awards. As the political coordinator for the Local Chris served on three congressional panels and advised our representatives in Congress on the issues that affect America's workers and has lobbied for laws to protect the rights and safety of working men and women in Washington, Albany and Hartford.

In these trips he also spoke up about the need to keep the budgets focused on education because he did not want to see our children forgotten in favor of a pet project somewhere in the state. He thought his political involvement came to its peak when he and his wife Anne were invited to attend the Clinton inauguration in 1997, but when he was invited to attend the Obama inauguration and ball two months ago to, it capped his pre-retirement.

During his 38+ years here, he has been invited to lecture at New York University, SUNY, Westchester Community College and Cornell University. At Cornell he developed a labor history course that was taught in high schools. His community involvement included fundraising for the American Red Cross, the Boy Scouts of America and the Olympics, and has served on the Board of Directors of the Child Care Council and the United Way. He was also the Vice President of the Westchester/Putnam Central labor Body that represents over 110,000 union men and women.

It was Chris' love for his Union that kept him out very late at night twisting the arms of local town, village and city officials regarding the need for them to approve the Verizon cable franchise agreements. He attended every town board meeting (sometimes on three and four separate occasions) that saw 34 franchise agreements out of the 34 he fought for. 34 – 0 is a pretty good batting average.

On February 15th, Chris made his decision to retire from Verizon and Local 1103. He and his wife plan to spend their time being grandparents for their three grandchildren and going to Yankee games. I know I speak for all the Members he has helped along the way when I say – We love you man and we will miss you.

involved is sharp and will require patience, however, be confident that your rights are being protected and that any concerns you may have are being addressed professionally.

On January 22, 2009, CWA Local 1103 conducted a New Members Meeting where many items were discussed, including

our union history, our union structure, union provided and union bargained benefits, the contract, and company policies. Each CWA Local 1103 Board Member discussed a specific topic. Vice President Kevin Sheil gave a contractual explanation, including the "carve outs" and a brief overview of sickness and accident disability. Secretary Treasurer Doug Sheahan talked about Dues Authorization and explained what an Agency Shop is. Business Agent

John Gentile discussed safety in the workplace, including our local's resources, contacts and commitment to safety. Business Agent Mark Crumm spoke about the union structure and provided insight into the day to day responsibilities of CWA Local 1103's union leaders. Mark voiced the history of Gerry Horgan, our brother, killed on the picket line in 1989 fighting for all of us, because for Mark, it isn't some abstract idea, he lived it. He explained how it was personal to

him because Gerry wasn't just a coworker, he was his friend. Business Agent Joe Mayhew spoke about our union Member benefits and our support for the Maria Ferrari Children's Hospital. Business Agents Anthony Pugliese and Kevin Scrobola shared their time and addressed incidental absence, holidays, EWD's and overtime payments. Next Step

Director **Scotty Cairney** was also present and discussed the TTA program and its many benefits. Area Chief Steward **Pete Scala** and Chief Steward **Mary Beth Morra** were introduced to the group and were integral in setting up the meeting. The meeting also included a question and answer session where our new Members were free to ask or comment about anything that was on their mind.

On February 5, 2009 at Hor-

gan Hall, CWA Local 1103 and representatives from CWA District 1 met with Verizon Service Corporation management and representatives from Verizon Labor Relations to discuss contractual items, such as schedule posting requirements, overtime list procedures and pay problems. We introduced specific concerns that our new Members are having, for example, the

contention that some are being paid at the wrong rate of pay in the wage progression pay scale, some have not received night differential for night tours worked, and some are still being asked to do management work. The Union requested a job description breakdown and the process utilized by the company when job titles were assigned to employees. The meeting was informative and cordial, with the company agreeing to a request to allow the union to conduct an orientation

company worksites.

At the time of this article, the local's representatives had already met with our new Members in White Plains, Elmsford, and Stamford, Ct. We look forward to servicing you, the new CWA Member. also receive a second-year scholarship of the same amount contingent upon satisfactory academic ac-


complishment. Part-time students (less than 12 credits) will receive half of the scholarship monies. No specific studies are required. Scholarship winners may pursue whatever course they wish.

31st Annual Daniel L. Keenan Memorial Scholarship \$2.000.00

Respecting the memory of our late President, who served in that office from 1964 to 1979.

36th Annual Eugene J. Mays Memorial Scholarship \$1,500.00

In remembrance of our late District One A.V.P., who served as Defense Fund Director during the 1971-72 N.Y. Telephone strike.

26th Annual Howard T. Miles Memorial Scholarship \$1,500.00
