# As I see it . . .



I want to thank everyone who responded to our request to e-mail or write New York **State Senator Steven Saland (R-Poughkeepsie)** about supporting S.5124 the Telecommunications Reform Act, sponsored by **State Senator Vincent Leibell (R-Carmel)**. We

hope he will listen to his constituency and support this vital legislation. If you have not done so already, please e-mail him at [saland@senate.state.ny.us](mailto:saland@senate.state.ny.us). This companion legislation to "The Brodsky Bill" will allow New York State residents in rural and upstate communities access high speed internet via a statewide cable franchise agreement if it is enacted. Right now Verizon is against it because they want to pick and choose the communities that will only be lucrative for them and disregard everyone else. This bill not only insures access to everyone and has consumer protections written into it, the unwritten part of this legislation is even more important and potentially devastating if it does not become law.

Last month we wrote about Verizon's attempt to sell off its network in Vermont, New Hampshire and Maine to a small company call FairPoint Communications. If there is not a statewide cable franchise agreement in New York, this will open the door for Verizon to do the same thing and sell off its network in upstate New York leaving many CWA men and women out of a job and consumers left to fend for themselves. At this writing Senator Saland has received only 243 e-mails from Local 1103 Members, so keep up the pressure. When you contact the Senator, let him know that people should come before profit and that having a job and providing for your family always comes before collecting an unemployment check.


Verizon has requested early bargaining, and as of this writing, the Union is contemplating discussing this request with the company. And as promised, within hours of it happening, Members

who signed up for our web bargaining updates were notified of this fact.

Mobilization to secure a fair contract is just around the corner. To date not that many Members have sent us their e-mail addresses. The National Union has told us that they intend to coordinate a vigorous mobilization campaign in their efforts to secure a fair contract; therefore we need your e-mail addresses so you also can get the latest bargaining and mobilization information. Your benefits and your jobs will once again be on the line and we need everyone as active, informed and as mobilized as ever.

# Business Agents Attend Cornell Leadership School

This September at **Cornell University** in Ithaca, New York, the *Clara Allen Leadership School* was conducted with **Business Agents Mark Crumm, John Gentile** and myself attending. The week-long school provided intense training and education in an academic setting with the focus on enhancing the skills and values of union leaders. The curriculum was varied, but certainly relevant. Included in the instruction were topics as diversified

## SHAME ON WAL-MART, SHAME ON U.S.

**H**uman Rights Watch, in a recent study of Wal-Mart's union evasion strategy, heaped scorn on the giant retailer for creating a "palpable fear" among its workers with an "unabashed, sophisticated and aggressive strategy" to block workers seeking union representation. However, Wal-Mart's tactics wouldn't work if U.S. labor law adequately protected the rights of working American, the study said. The report documented 292 labor violations brought against Wal-Mart, with 101 cases upheld by the National Labor Relations Board. Those cases have been consolidated into 39 formal complaints, involving 17 administrative law judges' rulings that Wal-Mart had violated labor laws. Despite its reputation as biased in favor of employers, the NLRB in Washington only reversed 2 of those decisions.

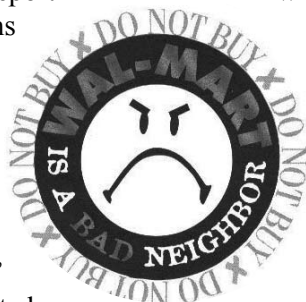
The product of a four-year investigation, the Human Rights Watch study underscored that Wal-Mart's oversized footprint opens the gates for similar exploitation by other employers. "Wal-Mart is a global industry leader and arguably a new model for 21<sup>st</sup> century business. Its decisions reverberate throughout the U.S. economy and beyond.

The company's choice on a wide range of operating policies matter, and its approach to workers' rights is no exception, the study noted.

**Carol Pier**, the author of the study, told the *New York Times*: "When the largest private employer in the United States seems to be able to violate U.S. labor law with virtual impunity, that's a very serious cause for concern, both with respect to its impact on its employees, but also on the conduct by other employers in the United States. With 1.3 million workers in its 4,000 stores, Wal-Mart should lead the way in establishing respect and dignity for workers, Human Rights Watch asserted. Instead, Wal-Mart has chosen to exploit "the many loopholes in U.S. labor law to undermine workers' freedom to decide whether to organize a union and, in the process, has become a poster child for what is wrong with U.S. labor law."

*Editor's Note: More than ever this proves that we need the Employee Free Choice Act enacted into law to protect U.S. workers.*
